Product description

"A-30 Deck, Steel with SeaRox SL 620"

Composed of structural steel deck insulated on the exposed side (underside of the deck) with minimum 25 mm thick mineral wool, type "SeaRox SL 620" (density 100-130 kg/m³) between and around the stiffeners.

The insulation is fixed to the deck by means of standard Ø 3 mm pins in combination with min. 30 mm diameter steel clips (spring washers).

Distance between pins on stiffeners and pins on the deck is approximately 300 mm.

For further details see reports and drawings listed under Type Examination documentation.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-30.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
